Therefore you are requested to quote rate item wise including GST & all taxes. The details of required items with the specifications are as below:-


1. Euphonium nickel plated 3volve with bag & mouth piece heavy quality

6. Clarinet 14 keys with imported reed mouth piece and bag
7. Brass Flute c scale best quality
8. Cymbal 12 inches brass
9. Maracas pair wooden with beads
10. Bugle copper brass mounted with bag
11. Leader stick
