**Terms & Condition (T&C)**


1. All the concerned suppliers from HP and from outside the state shall be eligible for bidding in the tender process.

Printing should be legible and After awarding the tender to L-1, the supplier will have to produce an affidavit not to leak any information related question paper of concerning class mentioned in supply order till the completion of SA-II examination in all the school of the district thereafter as well.
5. The supplier should be registered & having GSTIN Number & GST and PAN copy to be attached with bid tender documents and rate of taxes to be mentioned clearly.


