Interested firms are requested to submit their sealed quotations in the office of the undersigned on or before 02/03/2026 up to 11:00 AM. The tenders shall be opened on the same day at 1:00 PM in the presence of the tenderers or their authorized representatives and the Purchase Committee members.

The supply order shall be issued on the basis of the lowest evaluated tender.

**Eligibility Conditions:-**

1. The bidder must submit self-attested copies of:  
GST Registration Number.  
PAN Number.  
Aadhaar Number.
2. The bidder must have at least three (03) years of experience in printing works. Documentary proof must be attached.



3. The bidder must submit an undertaking on the firm's letterhead stating acceptance of all terms and conditions of the tender notice.

**Terms and Conditions:-**

1. The rates quoted shall be inclusive of all taxes, transportation charges, loading/unloading and F.O.R. delivery at designated block headquarters. No extra payment shall be admissible.

2. The material supplied must strictly conform to the specifications mentioned in the tender notice. Substandard material shall be rejected and replaced at the supplier's own risk and cost.

3. The successful bidder shall complete the supply within the stipulated time mentioned in the supply order, failing which penalty as deemed appropriate by the competent authority may be imposed.

4. Payment shall be made only after satisfactory supply and verification of the material by the concerned committee.

5. The office reserves the right to accept or reject any or all tenders without assigning any reason. The tender may be cancelled at any stage by the Deputy Director (Quality)-cum-DPO, DIET Bilaspur at Jukhala on administrative grounds without assigning any reason.
