Subject: Ensuring proper Teaching Learning Process inside the classroom by
all School Heads.

Memo:

1. The Country-wide sample survey was taken up to ascertain students achievement levels in three subjects i.e. Reading comprehension (language), Mathematics and Environment Studies (EVS).
2. NCERT has prepared a report on the findings of this National Achievement Survey entitled "What Students of Class V Know and Can Do". This report can be accessed on the web link as under:

3. I am enclosing a copy of the "State Report Card" for Himachal Pradesh which provides a snapshot of the performance of students in our State. The salient features of the findings of the survey are:

- (a) Percentage of students who scored less than 35%
 - a. 35% of students in Language,
 - b. 30% of students in Mathematics and
 - c. 25% of students in EVS.

- (b) Percentage of students who scored above 75%
 - a. 11% students in language,
 - b. 10% students in Mathematics and
 - c. 13% students in EVS

(c) Focus is required on the following subject wise competencies as less than 50% students could answer the items correctly in these topics

- Language- Grasping ideas and inference
- Mathematics- Measurement
- EVS- Family & Environment, Food, Travel and Real life topics

4. Therefore, it is essential to monitor and measure the learning outcome of each child and bring about significant improvement in learning achievement of students.

In order to ensure that every child attains class appropriate learning the following measures are to be undertaken by each School Head with immediate effect.

- Each school head would capture observation about every class teacher about the methodology of transaction of a lesson on the enclosed format and submit the same to State Project Director, RMSA at spdssahp@gmail.com.
- All the teachers have to keep their teacher's diary updated and enter the contents of lesson material which they transact in the class room. The school head is to ensure that the teacher diary is kept updated by

- all the teachers. The teachers can also refer to the Swayamsidham Portal for the detailed guidelines about how a teacher should construct a lesson plan, transact the lesson plan and conduct assessment. This entire material for the reference of the teachers has been uploaded on the portal in the form of teacher guide book.
- (c) All the School heads to identify all such teachers who are found weak in transaction of curriculum and report the need for their training to the State Project Director RMSA on a regular basis on the enclosed format.
- (d) The training of teachers should be conducted in a holistic manner and henceforth no teacher will abstain from teacher training. The issue of absenteeism from Teacher Training shall be considered as disobedience of Government order and action as per conduct rules would be initiated accordingly.

In order to enhance the learning outcome of children, it is, therefore, essential that all the school heads focus on measurement of learning outcomes of each child and introduce remediation as per need right from the beginning of the academic year so that every child attain class appropriate learning in all the subjects. The State is organizing SLAS for all the classes right from class I to 8th and it should be endeavor of each school head that the students achieve class appropriate learning outcome. Similarly for higher classes, the number of students having competencies below 35% should be bare minimum.
